I have been a MDUSD Parent for over 15 years and this is my way to "pay it forward". I am an immigrant who did not speak English when I came to this country. I would be able to relate to those families who were in a similar situation that I was in when I first arrived. I also feel it's important for students to know that they too have a voice and we as a community want to

support them and see them succeed.

The school board is responsible for: Hiring and evaluating the Superintendent Establishing policies for governing the school district Adopting a balanced budget each year Having legal and fiduciary authority for the school district Serving as community representatives to the district and on behalf of the district. 1.3 - What are your personal or professional qualifications that you believe make you the best candidate?

My journey to this election is personal. In 1976, I moved to the US at the age of 7. Barely speaking English, I fell behind in the classroom—frequently attending ESL (English as a Second Language) sessions just to keep pace with my peers. My parents—both without a college degree—often worked long hours operating a small clothing store in Daly City.

In 1993, I graduated from San Francisco State University with a degree in Business Administration. My husband and I moved to Concord in 2002—ready to raise our three children, Zeenat, Azeema, and Aasim. All of three of them would go on to attend schools in Trustee Area 5 (Mt. View Elementary, El Dorado Middle School, and Concord High School). In many ways, this district helped me raise my children. The schools were a second home and the teachers were second parents.

Outside of my career running a local small business, I have spent thousands of hours volunteering in our schools. In 2011, I helped establish and operate a local non-profit that provided scholarships and school supplies to MDUSD students. And now, I'm ready to take the next step in serving my schools: running for office.

1.4 - What are your top goals for this office? How do you plan on achieving them? *

My priorities are:

Welcoming Schools: where every student and family feels accepted and engaged Mental Health & Wellbeing: for students, teachers, and staff Enhanced Career Pathways: to local apprenticeships and higher education

I am an immigrant who came to this country at the age of 7, barely speaking English with parents who did not have college degrees. There was a feeling of loneliness and fear that I experienced which is why I want to make sure that the families that are new to our district not only feel welcomed but are engaged in their children's education.

I want to be able to continue the work that is currently being focused on the Mental wellbeing of our students and teachers. I want to make sure we continue to provide support throughout the school year especially during the times where students and teachers are feeling the most stress. There are Non Profits in the Bay Area that will come in to provide training to students from Elementary to High School Students. District mental health and wellness teams can offer support to teachers as well. For example, teams could provide training during professional development days or create a referral list of mental health providers in the community.

We have a community where many small businesses have been thriving for years. We can introduce the different industries into the classroom exposing the students to different career pathways. A database can be created of local business leaders who are interested in coming into the classrooms and speaking to the students. Internships can also be set up for High School Students through these businesses.

1.5 - How do you plan on engaging your constituents in dialogue after you are elected? *

As a Board Member it's important to build relationships with the schools the Area that your are elected for, what that means to me is that they need to know that you are accessible and that you are willing to listen to them. It is absolutely crucial that you make time to visit the sites and talk to students, teacher and the staff.

It is absolutely a must that our students feel that they feel safe. If you have undocumented students on campus grounds there will also be a sense of fear that they will carry with them, which will prevent them from thriving in the classroom. We need to always create a welcoming environment for our students, not one that creates fear.

We need to also make sure that are promoting green spaces in schools (ie. gardens).


