- 1. Enhance Community Services: I am committed to improving the quality of life in Concord by enhancing community services, drawing on my experience as Park, Open Space, and Recreation Commissioner and Monument Impact Board Chair.
- 2. I will continue my work to improve our infrastructure. I led the Measure V initiative, which is the city's 1% (one cent) rate use and transaction tax. I will ensure the \$30 million in revenue is spent to improve Concord roads as promised.
- 3. Promote Safety and Well-Being: I prioritize the safety and well-being of our community by investing in well-lit streets and accessible parks, supporting our firefighters/police, and working with County and State leaders to provide mental health services and affordable housing.

A city council member is responsible for representing the interests of their constituents and making key decisions that shape the future of the city. They draft and vote on local laws, approve the city's budget, and allocate funds for essential services like public safety and infrastructure. Council members act as a bridge between residents and the city government, addressing community concerns and advocating for their needs. They play a vital role in policy development, oversight of city departments, and planning and zoning decisions, all while engaging with the community to ensure informed and inclusive governance.
